CERTIFICATE OF SURVEY FOR LINDA CUNNINGHAM OF TAX PARCEL 014-046701 IN THE SE'4 OF THE SW'4 OF SECTION 21, T.17N., R.14E., TOWN OF NEPEUSKUN, WINNEBAGO COUNTY, WISCONSIN.

I, Dennis M. Green, Professional Land Surveyor in the State of Wisconsin, hereby certify that by the order of Linda Cunningham, I have surveyed, monumented and mapped lands located in tax parcel 014-046701 in the SE¼ of the SW¼ of Section 21., T.17N., R.14., Town of Nepeuskun, Winnebago County, Wisconsin being more particularly described as follows:

Commencing at the Southwest Corner of the SE¼ of the SW¼ of said Section 21; thence N90°-00°-00°E along the South line of the SW¼ of said Section 21, 28 rods or 462.00 feet to the intersection of said South line and the centerline of Rush Lake Loop Road; thence N41°-53'-00"E along said centerline, 243.79 feet to a point 11 rods or 181.5 feet North of said Section line being the Point of Beginning; thence N41°-53'-00"E along the centerline of said Rush Lake Loop Road, 223.18 feet; thence S00°-00'-00"E, 166.16 feet; thence S90°-00'-00"W parallel to Section line, 149.00 feet to the Point of Beginning. Said parcel subject to a Right of Way for Rush Lake Loop Road over the Northwesterly side thereof as shown on Page 1. Parcel also being subject to all other easements and restrictions of record, if any. Said parcel contains 12,379 square feet or 0.28 acres. All bearings referenced to the South line of the SW¼ of Section 21 assumed to bear N90°-00'-00"E.
