KNOWN AS 4582 BELLHAVEN LANE. THAT PART OF GOVERNMENT LOT 2 OF FRACTIONAL SECTION 7, T18N, R16E, TOWN OF ALGOMA, WINNEBAGO COUNTY, WISCONSIN WHICH IS BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE W. 1/4 CORNER OF SAID SECTION 7, THENCE NORTH 00°45'57" WEST ALONG THE WEST LINE OF THE N.W. 1/4 OF SAID SECTION 2182.10 FT., THENCE SOUTH 80°37'48" EAST 314.26 FT. TO THE POINT OF BEGINNING OF THE PARCEL TO BE DESCRIBED, THENCE NORTH 19°58'33" EAST 255.94 FT. TO THE START OF A MEANDER LINE AND A POINT THAT IS 9 FT. MORE OR LESS FROM THE SHORELINE OF LAKE BUTTE DES MORTS, THENCE SOUTH 37°47'11" EAST ALONG SAID MEANDER LINE 138.29 FT. TO THE END OF SAID LINE AND A POINT THAT IS 27' MORE OR LESS FROM THE SHORE OF SAID LAKE, THENCE SOUTH 24°48'15" WEST 127.97 FT. TO A POINT ON THE NORTHWESTERLY LINE OF LOT 1 OF CERTIFIED SURVEY MAP NO. 1002, THENCE SOUTH 20°39'23" WEST ALONG SAID LINE 113.94 FT. TO THE SOUTHWESTERLY MOST CORNER OF SAID LOT AND A POINT ON THE NORTH RIGHT-OF-WAY LINE OF BELLHAVEN LANE, THENCE NORTH 80°37'48" WEST ALONG SAID LINE 128.06 FT. TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 0.7388 ACRES TO THE MEANDER LINE AND INCLUDES ALL LANDS LYING BETWEEN THE DESCRIBED MEANDER LINE AND THE SHORELINE OF SAID LAKE BUTTE DES MORTS. 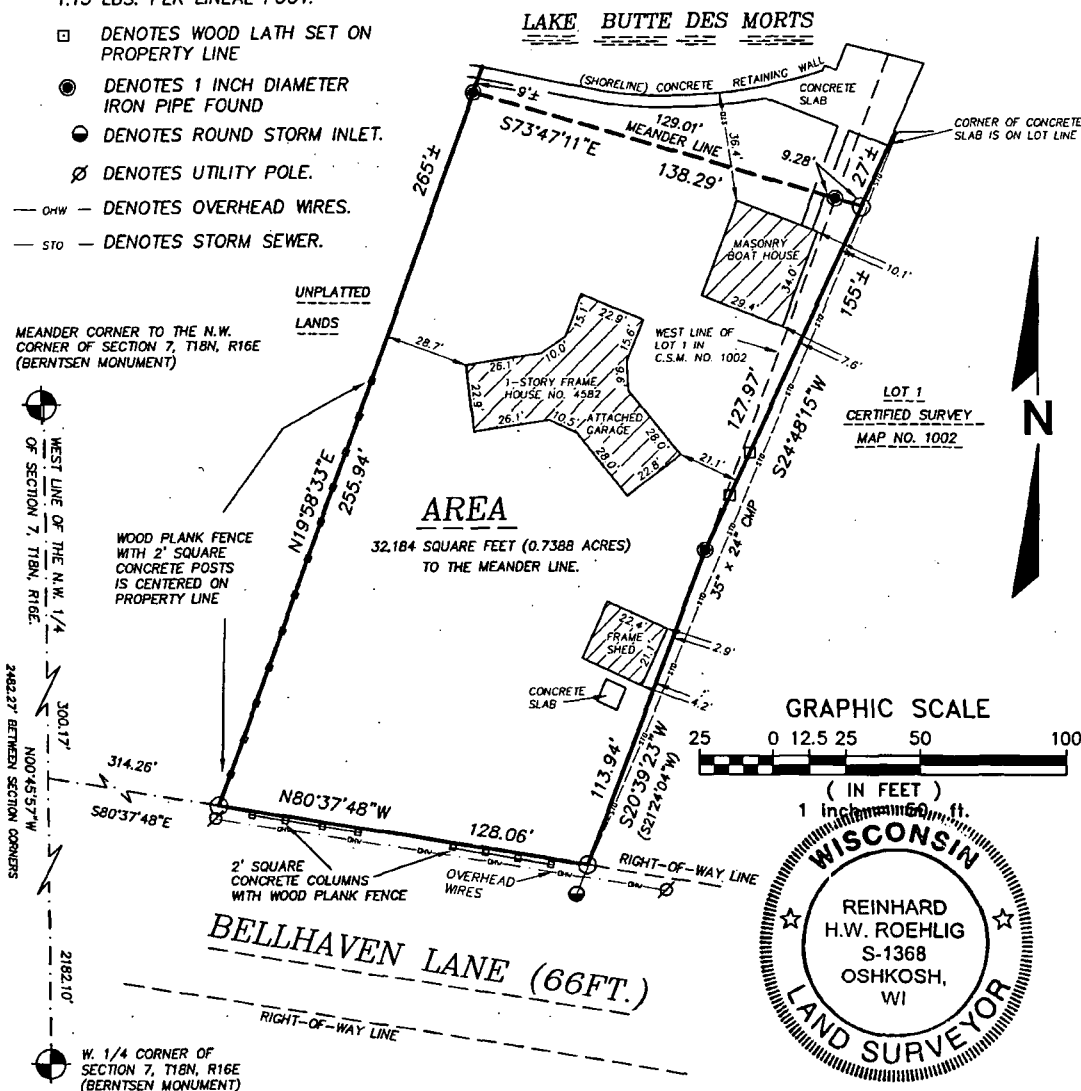

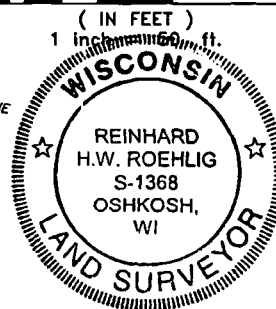
