

## PLAT OF SURVEY

PART OF LOT 16, RATH'S ADDITION TO THE TOWN OF ALGOMA AND PART OF OUTLOT 2, CERTIFIED SURVEY MAP NO. 4243, ALL IN IN THE SW 1/4 OF THE NW 1/4 OF SECTION 15, TOWNSHIP 18 NORTH, RANGE 16 EAST, CITY OF OSHKOSH, WINNEBAGO COUNTY, WISCONSIN

## **LEGAL DESCRIPTION:**

Part of the lands described in Document No. 19452530, being part of Lot 16, Rath's Addition to the Town of Algoma and part of Outlot 2 of Certified Survey Map No. 4243, recorded as Document No. 1058517, all in the SW 1/4 of the NW 1/4 of Section 15, Township 18 North, Range 16 East, City of Oshkosh, Winnebago County, Wisconsin, described as follows:

Commencing at the West 1/4 corner of said Section 15; Thence N01°26'13"W, 330.28 feet along the West line of the Northwest 1/4 of said Section 15; Thence N89°15'26"E, 100.15 feet along the North line of said Lot 16 to the Southwest corner of Lot 1 of Certified Survey Map No. 5820, recorded as Document No. 1376851; Thence continuing N89°15'26"E, 6.00 feet along said North line of Lot 16, the South line of said Lot 1, and the North line of Outlot 2 of Certified Survey Map No. 4243, recorded as Document No. 1058517 to the point of beginning; Thence continuing N89°15'26"E, 63.05 feet along said North line of Lot 16, said South line of Lot 1, and said North line of Outlot 2 to the Northeast corner of said Lot 16, the Northwest corner of Lot 2 of said Certified Survey Map No. 5820, and the Northeast corner of said Outlot 2; Thence S00°35'34"E, 265.66 feet along the East line of said Lot 16, the West line of said Lot 2, and the East line of said Outlot 2; Thence N15°01'01"W, 169.67 feet; Thence N09°20'25"W, 59.46 feet; Thence N16°04'10"W, 44.00 feet to the point of beginning.

Described parcel contains 8,652 sq. feet, 0.198 acres, more or less.
