15 FOOT WIDE INGRESS/EGRESS EASEMENT

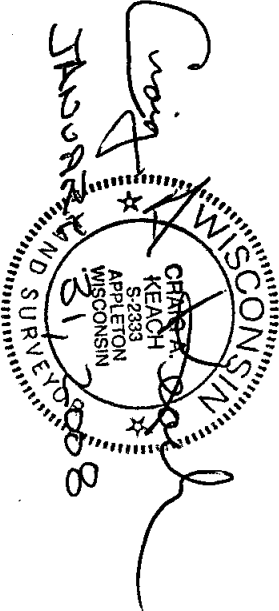
Part of the Southeast Quarter (SE ¼) of the Northeast Quarter (NE ¼) of Section Twenty Two (22) Township Eighteen (18) North, Range Sixteen (16) East City of Oshkosh, Winnebago County Wisconsin containing 3,404 square feet (0.078 acres) of land and being 7.5 feet each side of and parallel to the following described line:

Commencing at the East Quarter corner of said Section 22; thence N89 °-57'-34"W 237.62 feet along the South line of the NE ¼ of said Section 22; thence N00 °-02'-26"E 482.33 feet; thence N00°-45'-55"W 22.00 feet; thence N89°-14'-05"E 46.36 feet; thence N58°-23'-06"E 7.15 feet to the point of beginning; thence N00°-45'-55"W 22.33 feet; thence N42°-06'-06"E 4.07 feet to a point herein after referred to as "Point A" thence N47°-53'-54"W 17.00 feet to the point of termination. Also beginning at said "Point A" thence N42°-06'-06"E 63.62 feet; thence N61°-47'-39"E 63.82 feet; thence N89°-44'-49"E 56.12 feet to a point on the West Line of Knapp Street and the point of termination. The side lot lines of said easement shall be shortened or lengthened to terminate on the West Line of Knapp Street.

Commencing at the East Quarter corner of said Section 22; thence N89 °-57'-34"W 237.62 feet along the South line of the NE ¼ of said Section 22; thence N00 °-02'-26"E 482.33 feet; thence N00°-45'-55"W 22.00 feet; thence N89°-14'-05"E 46.36 feet; thence N58°-23'-06"E 11.23 feet to the point of beginning; thence N00°-45'-55"W 19.10 feet; thence N42°-06'-06"E 7.04 feet to a point herein after referred to as "Point B" thence N89°-14'-05"E 21.19 feet to the point of termination. Also beginning at said "Point B" thence N42°-06'-06"E 58.70 feet; thence N61°-47'-39"E 62.13 feet; thence N89°-44'-49"E 55.25 feet to a point on the West Line of Knapp Street and the point of termination. The side lot lines of said easement shall be shortened or lengthened to terminate on the West Line of Knapp Street.
