


# **TOPOGRAPHIC MAP CLAIRVILLE SITE PROJECT**

### Prevailing Wind Direction

Per WindSpark, the predominant average hourly wind direction in Oshkosh varies throughout the year. The wind is most often from the north for 1.3 months, from March 5 to April 13, with a peak percentage of 32% on March 8. The wind is most often from the south for 1.1 months, from May 10 to June 14 and for 1.4 months, from August 17 to September 29, with a peak percentage of 35% on September 6. The wind is most often from the west for 2.1 months, from June 14 to August 17 and for 5.2 months, from September 29 to March 5, with a peak percentage of 35% on July 19.

#### Vertical Control




