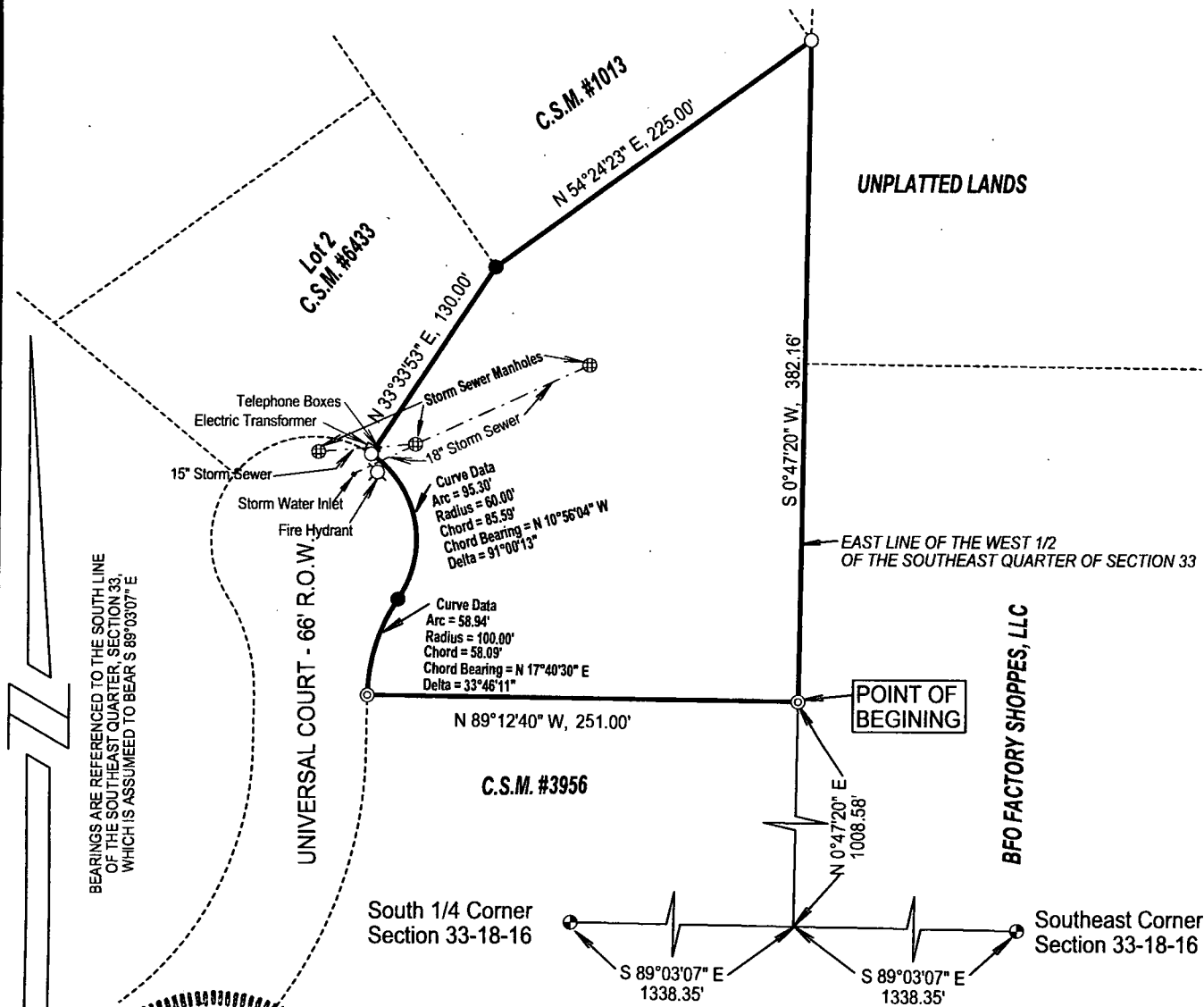


PLAT OF SURVEY

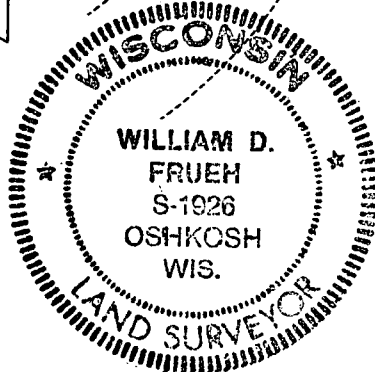

LEGAL DESCRIPTION

COMMENCING at the South Quarter Corner of said Section 33, Township 18 North, Range 16 East; thence S 89°03'07" E, along the South Line of the Southeast Quarter of said Section 33, a distance of 1338.35 feet, to the East Line of the West Half of the Southeast Quarter of said Section 33; thence N 0°47'20" E, a distance of 1,008.58 feet, to the Northeast Corner of Certified Survey Map Number 3956, which is also the POINT OF BEGINNING; thence N 89°12'40" W, along the North line of said CSM # 3956, a distance of 251.00 feet, to the east right of way of Universal Court and to the point of curvature of a non-tangent curve, concave to the east, having a radius of 100.00 feet, a central angle of 33°46'11", and a chord of 58.09 feet bearing N 17°40'30" E; thence Northerly along said curve, a distance of 58.94 feet to the point of curvature of a non-tangent curve, concave to the west, having a radius of 60.00 feet a central angle of 91°00'13", and a chord of 85.59 feet bearing N 10°56'04" W; thence Northerly along said curve, a distance of 95.30 feet, to the southeasterly corner of Lot 2, Certified Survey Map Number 6433; thence N 33°33'53" E, along the Southeasterly side of said CSM #6433, a distance of 130.00 feet, to the Southerly Corner of Certified Survey Map Number 1013; thence N 54°24'23" E, along the southerly side of said CSM #1013, a distance of 225.00 feet to the East Line of the West Half of the Southeast Quarter of said Section 33; thence S 0°47'20" W, a distance of 382.16 feet to the POINT OF BEGINNING; said described tract containing 68,675 Square Feet (1.5766 Acres), more or less.
