
Village of Winneconne Description for Street Vacation - Jefferson St.

A part of the Plat of Williamsport, Village of Winneconne, Winnebago County, Wisconsin, described as follows: Beginning at a Harrison Monument found at the intersection of the South Line of Jefferson Street with the West Line of South Fifth Street; thence West along the South Line of Jefferson Street a distance of 268 feet more or less to the West Line of the Plat of Williamsport; thence North 66 feet along the West Line of the Plat of Williamsport to the North Line of Jefferson Street also being the South Line of Block 9, Plat of Williamsport; thence East along the North Line of Jefferson Street, also being the South Line of said Block 9, 268 feet more or less to the West Line of South Fifth Street; thence South 66 feet to the point of beginning.

WHEREAS, the Village Board of the Village of Winnsconne has reason to be converned, and has deliberated as to vacating that portion of Jaffarson Street Wast to Block 19, Ripon Addition, from the intersection of South Fifth Street, in the Village, and bereinefter Gescribed, and that vacating of said street as identified would be in the public's interest, and requires a public hearing to inform the public of a determination to be made by the Village Board: RESOLVED, that a public hearing on the passage of a resolution be held by the Village Board on the 20th day of June, 1974, at 7:30 o'clock P.M. in the Village Hall, Village of Hinnsconne. That notice of such hearing be given by publication in the official Village paper, Winneconne News. That notice of such hearing shall be given and served on the owners of all frontage of lots and lands abutting upon that portion sought to be wasated and discontinued.
