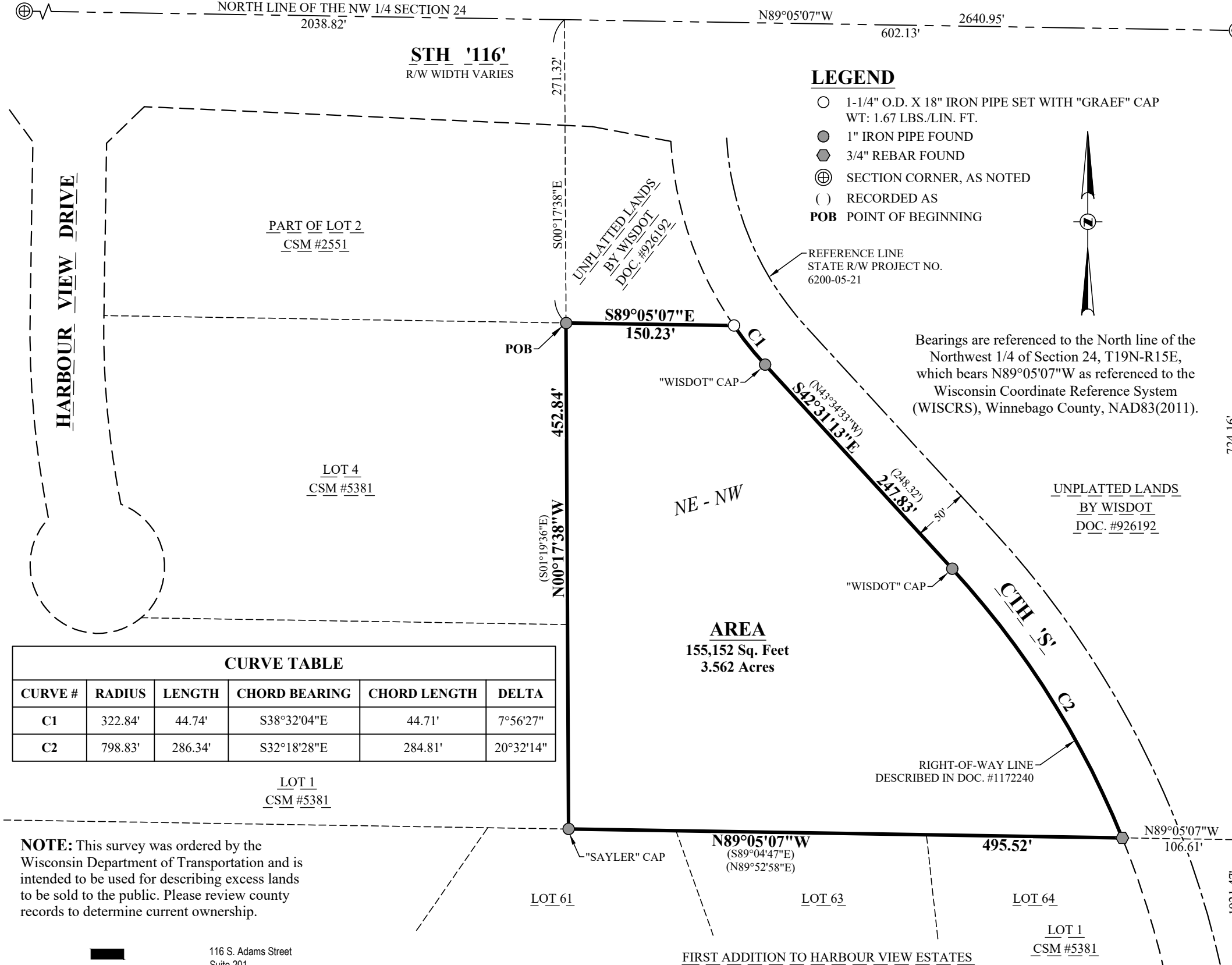


# PLAT OF SURVEY

### LEGAL DESCRIPTION:

Part of the Northeast 1/4 of the Northwest 1/4 of Section 24, Township 19 North, Range 15 East, Town of Winneconne, Winnebago County, Wisconsin, fully described as follows:

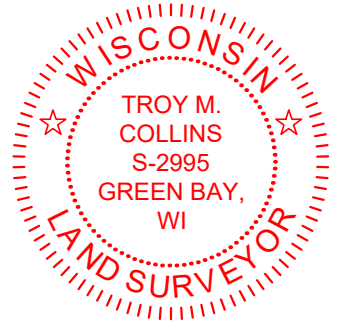
Commencing at the North 1/4 corner of said Section 24; Thence N89°05'07"W, 602.13 feet along the North line of the Northwest 1/4 of said Section 24; Thence S00°17'38"E, 271.32 feet to the Northeast corner of Lot 4 of Certified Survey Map No. 5381, being the Point of Beginning; Thence S89°05'07"E, 150.23 feet to the Westerly right-of-way line of CTH 'S' (Southwest Frontage Road) as described in Document No. 1172240; Thence Southeasterly 44.74 feet along said Westerly right-of-way line, being the arc of a 322.84-foot radius curve to the left having a long chord which bears S38°32'04"E, 44.71 feet; Thence S42°31'13"E, 247.83 feet along said Westerly right-of-way line; Thence Southerly 286.34 feet along said Westerly right-of-way line, being the arc of a 798.83-foot radius curve to the right having a long chord which bears S32°18'28"E, 284.81 feet to the Northeast corner of Lot 64 of the First Addition to Harbour View Estates and the Northeast corner of Lot 1 of said Certified Survey Map No. 5381; Thence N89°05'07"W, 495.52 feet along the North line of Lots 64, 63, and 61 of said plat and the North line of said Lot 1; Thence N00°17'38"W, 452.84 feet along the East line of said Lots 1 and 4 to the Point of Beginning.

Described parcel contains 155,152 Sq. Feet (3.562 Acres) more or less, and is subject to all easements and restrictions of record.

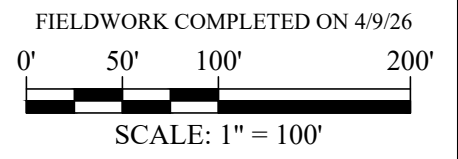
