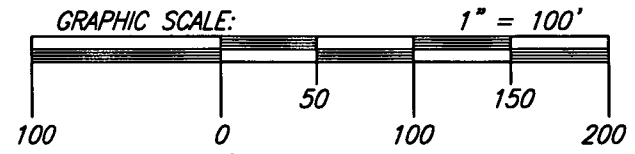


"PLAT OF SURVEY"
