

Part of Lot 2 of CSM #5888 located in the SE 1/4 of the NE 1/4, and the SW 1/4 of the NE 1/4 of Section 2, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin, described as follows:

Commencing at the East Quarter Corner, thence S89°22'49"W, along the south line of the NE 1/4, 700.72 feet to the Point of Beginning. Thence continuing S89°22'49"W, along said south line, 1866.28 feet to the Center of Section, marked by an aluminum monument; thence N00°17'19"W, along the west line of Lot 2 of CSM #5888, 1318.08 feet to the north line of said Lot 2; thence N89°22'23"E, along said north line, 1285.27 feet; thence S00°12'42"E, 411.00 feet to a north line of said Lot 2; thence N89°22'23"E, along said north line, 1240.11 feet to the westerly right of way of STH 76; thence S00°20'26"E, along said westerly right of way line, 246.00 feet to the north line of Lot 1 of said CSM; thence S89°22'25"W, along said north line, 656.95 feet to the west line of said Lot 1; thence S00°07'50"E, along said west line of Lot 1, 661.33 feet to the Point of Beginning.


