

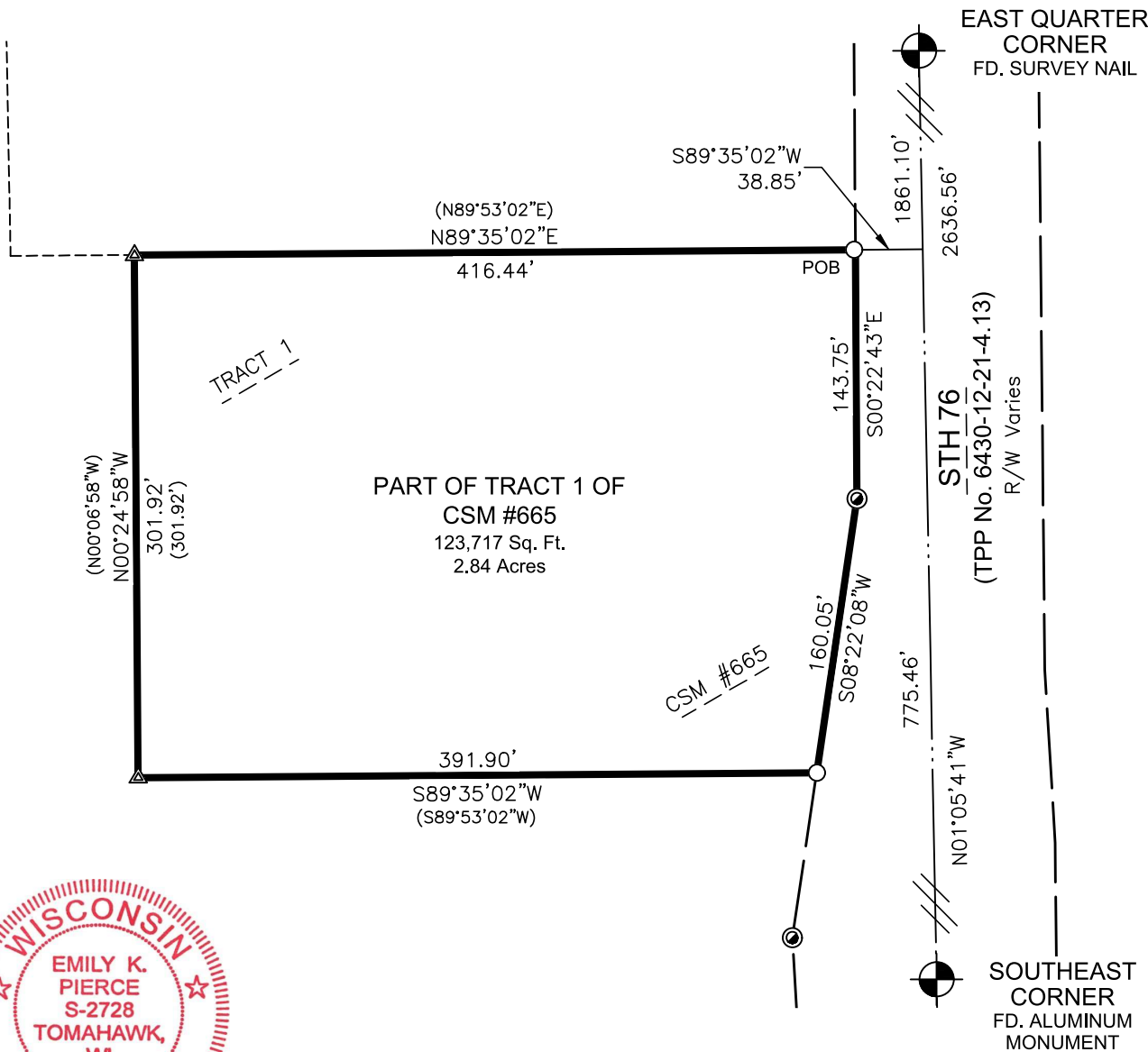

## WINNEBAGO COUNTY PLAT OF SURVEY

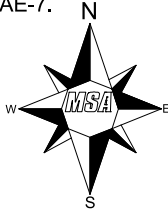

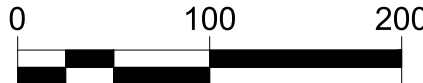

### PARCEL DESCRIPTION

Part of Tract 1 of CSM #665, located in the SE 1/4 of the SE 1/4 of Section 2, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin, described as follows:

Commencing at the Southeast Corner, thence N01°05'41"W, along the east line of the SE 1/4, 775.46 feet; thence S89°35'02"W, 38.85 feet to the westerly right of way of STH 76 and the Point of Beginning. Thence S00°22'43"E, along said right of way, 143.75 feet; thence S08°22'08"W, along said right of way, 160.05 feet to the south line of Tract 1 of CSM #665; thence S89°35'02"W, along said south line, 391.90 feet to the west line of said Tract; thence N00°24'58"W, along said west line, 301.92 feet to the north line of said Tract; thence N89°35'02"E, along said north line, 416.44 feet to the Point of Beginning.

Parcel contains 123,717 square feet or 2.84 acres.

NOTE: Purpose of this survey is to monument property corners of previously surveyed properties at R/W after TPP/acquisition. Companion surveys nearby done simultaneously.
