

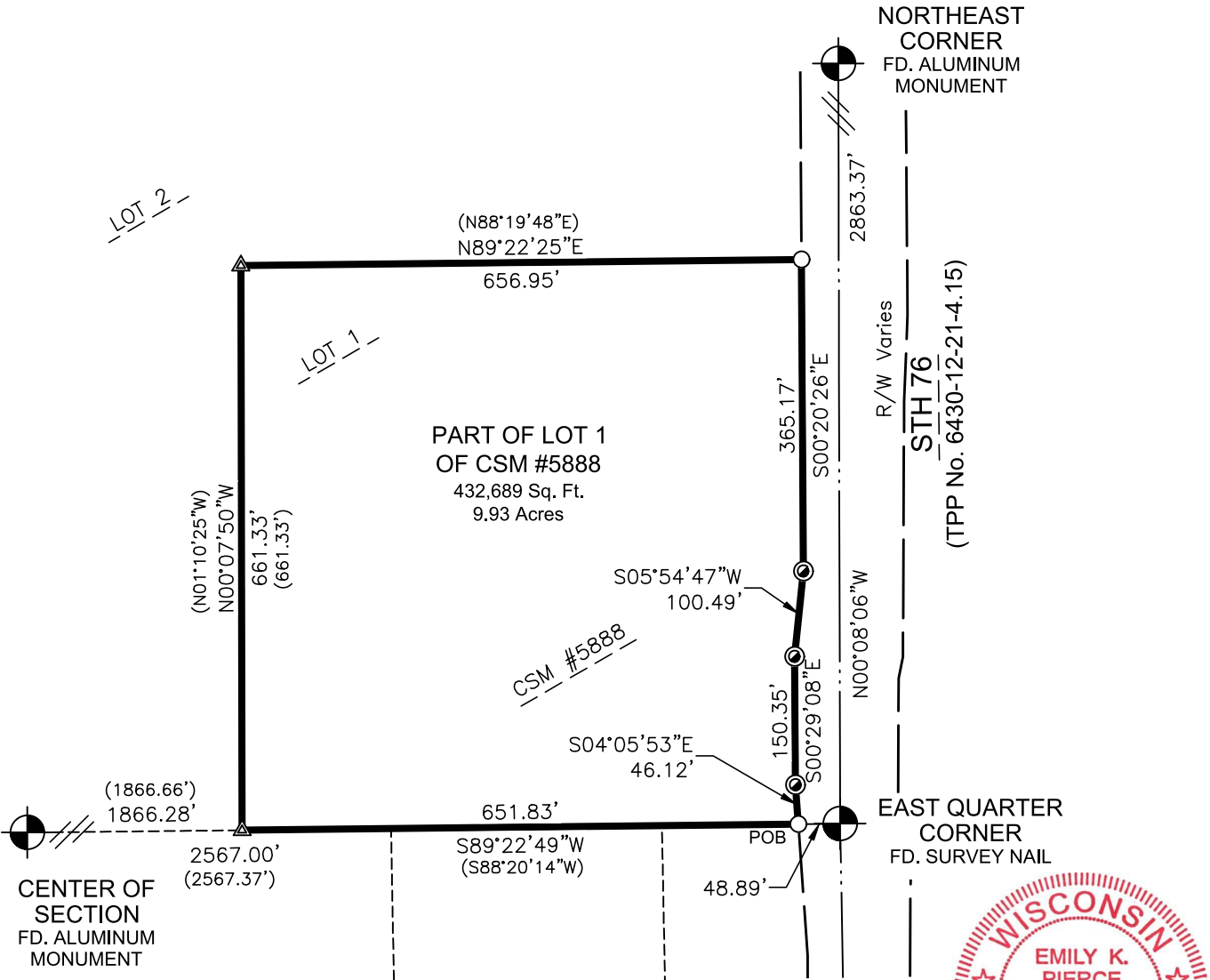

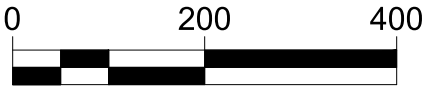

PARCEL DESCRIPTION

Part of Lot 1 of CSM #5888 located in the SE 1/4 of the NE 1/4 of Section 2, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin, described as follows:

Commencing at the East Quarter Corner, thence S89°22'49"W, along the south line of the NE 1/4, 48.89 feet to westerly right of way of STH 76 and the Point of Beginning. Thence continuing S89°22'49"W, along the south line of the NE 1/4, 651.83 feet to the west line of Lot 1 of CSM #5888; thence N00°07'50"W, along said west line, 661.33 feet to the north line of said Lot 1; thence N89°22'25"E, along said north line, 656.95 feet to said westerly right of way; thence S00°20'26"E, along said right of way, 365.17 feet; thence S05°54'47"W, along said right of way, 100.49 feet; thence S00°29'08"E, along said right of way, 150.35 feet, thence S04°05'53"E, along said right of way, 46.12 feet to the Point of Beginning.

Parcel contains 432,689 square feet or 9.93 acres.
