

PARCEL DESCRIPTION

Part of Lot 1 of CSM #5179 in the SE 1/4 of the NE 1/4 of Section 11, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin; described as follows:

Commencing at the East Quarter Corner, thence S89°16'02"W, along the south line of the SE 1/4 of the NE 1/4, 48.50 feet to the westerly right of way of STH 76 and the Point of Beginning. Thence S89°16'02"W, along the south line of Lot 1, 653.17 feet to the west line of said Lot 1; thence N00°32'04"W, along said west line, 334.27 feet to the north line of said Lot 1; thence N89°16'01"E, along said north line, 647.94 feet to the westerly right of way of STH 76; thence S00°35'41"E, along said westerly right of way, 52.60 feet; thence S03°53'25"E; along said right of way, 100.13 feet; thence S00°35'41"E, along said right of way, 149.57 feet; thence S00°08'13"E, along said right of way, 32.14 feet to the Point of Beginning.

Said Parcel contains 217,815 square feet or 5.00 acres.
