

PARCEL DESCRIPTION

Part of Lot 1 of CSM #1137 in the SE 1/4 of the NE 1/4 of Section 11, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin; described as follows:

Commencing at the East Quarter Corner, thence N00°30'35"W, along the East line of the SE 1/4 of the NE 1/4, 491.50 feet; thence S89°25'19"W, 61.10 feet to the westerly right of way of STH 76 and the Point of Beginning. Thence S89°25'19W, along the south line of Lot 1 of CSM #1137, 765.65 feet to the west line of said Lot 1; thence N00°34'41"W, along said west line, 208.71 feet to the north line of said Lot 1; thence N89°25'19"E, along said north line, 208.71 feet; thence S00°34'41"E, along said north line, 142.71 feet; thence N89°25'19"E, along said north line, 557.21 feet to said westerly right of way; thence S00°20'47"E, along said right of way, 66.00 feet to the Point of Beginning.

Said Parcel contains 80,327 square feet or 1.84 acres.
