

Part of Lot 1 of CSM #2846 in the NW 1/4 of the SW 1/4 of Section 13, T19N, R16E, Town of Vinland, Winnebago County, Wisconsin; described as follows:

Commencing at the West Quarter Corner of Section 13, thence S00°14'27"E, 692.00 feet; thence N89°31'30"E, 52.93 feet to the easterly right of way of STH "76" and the Point of Beginning. Thence continuing N89°31'30"E along the north line of Lot 1 of CSM #2846, 214.87 feet to the east line of said Lot 1; thence S00°14'27"E, along said east line, 200.00 feet to the south line of said Lot 1; thence S89°31'30"W, along said south line, 214.83 feet to the easterly right of way of STH "76"; thence N00°15'12"W, along said easterly right of way, 200.00 feet to the Point of Beginning.


