

Thence S89°33'48"W, along the south line of Lot 1 of CSM #4100, 1256.87 feet; thence N00°40'56"W, along the west line of Lot 1, 559.13 feet; thence N89°42'13"E, along a north line of said Lot, 283.00 feet; thence N00°40'56"W, along a north line of said lot, 76.01 feet; thence N89°42'13"E, along a north line of said Lot, 439.81 feet; thence S00°17'47"E, along a north line of said Lot, 365.90 feet; thence N89°33'44"E, along a north line of said Lot, 385.43; thence S00°53'04"E, along a north line of said Lot, 104.28; thence N89°41'26"E, along a north line of said Lot, 149.01 feet to the westerly right of way of STH 76; thence S00°56'51"E, along said right of way, 158.43 feet; thence S13°30'06"E, along said right of way, 4.57 feet to the Point of Beginning.
