

DESCRIPTION

A PART OF THE NORTHEAST QUARTER (NE.1/4) OF THE SOUTHEAST QUARTER (SE.1/4) OF SECTION TWENTY-NINE (29), TOWNSHIP NINETEEN (19) NORTH, RANGE SIXTEEN (16) EAST, TOWN OF OSHKOSH, WINNEBAGO COUNTY, WISCONSIN CONTAINING 101 SQUARE FEET OF LAND AND BEING DESCRIBED AS FOLLOWS;

COMMENCING AT THE EAST QUARTER (E.1/4) CORNER OF SAID SECTION 29; THENCE S.89°24'12"W. 1078.15 FEET ALONG THE NORTHLINE OF THE SE.1/4 OF SAID SECTION 29 TO THE NORTHEAST CORNER OF TRACT-1 OF CERTIFIED SURVEY MAP NO. 552 RECORDED IN VOLUME 1 ON PAGE 552 OF CERTIFIED SURVEY MAPS TO THE POINT OF BEGINNING; THENCE S.00°11'17" E 9.65 FEET ALONG THE EAST LINE OF SAID TRACT 1; THENCE NORTHEASTERLY 34.94 FEET ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 60.00 FEET AND A CHORD OF WHICH BEARS N.73°07'42"E. 34.45 FEET TO A POINT ON THE NORTHLINE OF THE SE.1/4 OF SAID SECTION 29; THENCE S.89°24'12"W. 33.00 FEET ALONG SAID LINE TO THE POINT OF BEGININNG.
