


# PLAT OF SURVEY

DESCRIPTION: A PARCEL OF LAND IN THE NORTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 16, TOWNSHIP 19 NORTH, RANGE 17 EAST, TOWN OF VINLAND, WINNEBAGO COUNTY, WISCONSIN, MORE FULLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTH 1/4 CORNER OF SAID SECTION 16, THENCE PROCEEDING SOUTH 0°48' EAST, ALONG THE QUARTER LINE 435.5 FEET TO THE POINT OF BEGINNING, THENCE CONTINUING SOUTH 0°48' EAST, 100 FEET; THENCE SOUTH 87°58' WEST 198.43 FEET; THENCE NORTH 0°41" WEST 100 FEET; THENCE NORTH 87°58' EAST 198.23 FEET TO PLACE OF BEGINNING, SAID LAND BEING DESCRIBED AS LOT 5 OF THE PROPOSED BRAUNDALE SUBDIVISION. ALSO AN EASEMENT OF WAY FOR INGRESS AND EGRESS TO SAID PREMISES IS HEREBY GRANTED ACROSS LOT 24 OF THE PROPOSED BRAUNDALE SUBDIVISION FROM HIGHWAY "A" UNTIL SUCH TIME AS THE ROADWAY SHOWN ON SAID PLAT WHICH IS JUST WEST OF THE ABOVE PREMISES HEREIN CONVEYED IS OPENED TO PAYNE'S POINT ROAD AT WHICH TIME THIS EASEMENT OF WAY ACROSS LOT 24 SHALL TERMINATE AND THIS EASEMENT BE NO LONGER OF ANY FORCE OR EFFECT. SAID PARCEL BEING LANDS DESCRIBED IN DOCUMENT NUMBER 1398895.
