BEING PART OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 29 AND PART OF THE
NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 30, ALL BEING IN TOWNSHIP 19 NORTH,
RANGE 17 EAST, TOWN OF OSHKOSH, WINNEBAGO COUNTY, WISCONSIN.

LEGAL DESCRIPTION:

BEING PART OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 29 AND PART OF THE
NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 30, ALL IN TOWNSHIP 19 NORTH, RANGE 17 EAST,
TOWN OF OSHKOSH, WINNEBAGO COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS:
COMMENCING AT THE NORTH 1/4 CORNER OF SECTION 29; THENCE S89°12'46"W, 1315.78 FEET ALONG
THE NORTH LINE OF THE NORTHWEST 1/4 OF SECTION 29 TO THE EAST LINE OF THE NORTHWEST 1/4 OF
THE NORTHWEST 1/4 OF SECTION 29 AND THE POINT OF BEGINNING; THENCE S00°02'25"W (RECORDED
AS S00°23'59"E), 1321.16 FEET ALONG SAID EAST LINE TO THE SOUTH LINE OF THE NORTHWEST 1/4 OF
THE NORTHWEST 1/4 OF SECTION 29; THENCE S89°15'48"W, 1316.08 FEET ALONG SAID SOUTH LINE TO
THE NORTHEASTERLY RIGHT-OF-WAY LINE OF BRITISH LANE; THENCE N44°20'34"W, 589.65 FEET ALONG
SAID NORTHEASTERLY RIGHT-OF-WAY LINE TO THE SOUTHEASTERLY RIGHT-OF-WAY LINE OF C.T.H.
"A"; THENCE N01°33'18"E, 90.59 FEET ALONG SAID SOUTHEASTERLY RIGHT-OF-WAY LINE; THENCE
NORTHEASTERLY, 182.08 FEET ALONG THE ARC OF A 2667.32 FOOT RADIUS CURVE TO THE LEFT OF
SAID SOUTHEASTERLY RIGHT-OF-WAY LINE, HAVING A CHORD WHICH BEARS NN45°51'04"E AND IS
182.04 FEET IN LENGTH; THENCE N43°53'44"E, 194.23 FEET ALONG SAID SOUTHEASTERLY
RIGHT-OF-WAY LINE; THENCE NORTHEASTERLY, 548.11 FEET ALONG THE ARC OF A 6604.32 FOOT
RADIUS CURVE TO THE LEFT OF SAID SOUTHEASTERLY RIGHT-OF-WAY LINE, HAVING A CHORD WHICH
BEARS N41°31'05"E AND IS 547.95 FEET IN LENGTH; THENCE N39°08'26"E, 39.83 FEET ALONG SAID
SOUTHEASTERLY RIGHT-OF-WAY LINE; THENCE N86°06'05"E, 122.80 FEET ALONG SAID SOUTHEASTERLY
RIGHT-OF-WAY LINE; THENCE N72°24'50"E, 219.60 FEET ALONG SAID SOUTHEASTERLY RIGHT-OF-WAY
LINE TO THE SOUTH RIGHT-OF-WAY LINE OF INDIAN POINT ROAD; THENCE N00°47'14"W, 33.00 FEET
TO THE NORTH LINE OF THE NORTHWEST 1/4 OF SECTION 29; THENCE N89°12'46"E, 81.61 FEET
ALONG SAID NORTH LINE TO AN EAST LINE OF LANDS DESCRIBED IN DOCUMENT NO. 1745203;
THENCE S00°02'25"W, 264.00 FEET ALONG SAID EAST LINE TO A NORTH LINE OF SAID DESCRIBED
LANDS; THENCE N89°12'46"E, 494.87 FEET ALONG SAID NORTH LINE AND THE SOUTH LINE OF
LOT 1 OF CERTIFIED SURVEY MAP NO. 484 TO THE EAST LINE OF SAID LOT 1; THENCE
N00°02'25"E, 264.00 FEET ALONG SAID EAST LINE TO THE NORTH LINE OF THE
NORTHWEST 1/4 OF SECTION 29; THENCE N89°12'46"E, 165.13 FEET ALONG SAID
NORTH LINE TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 39.7156
