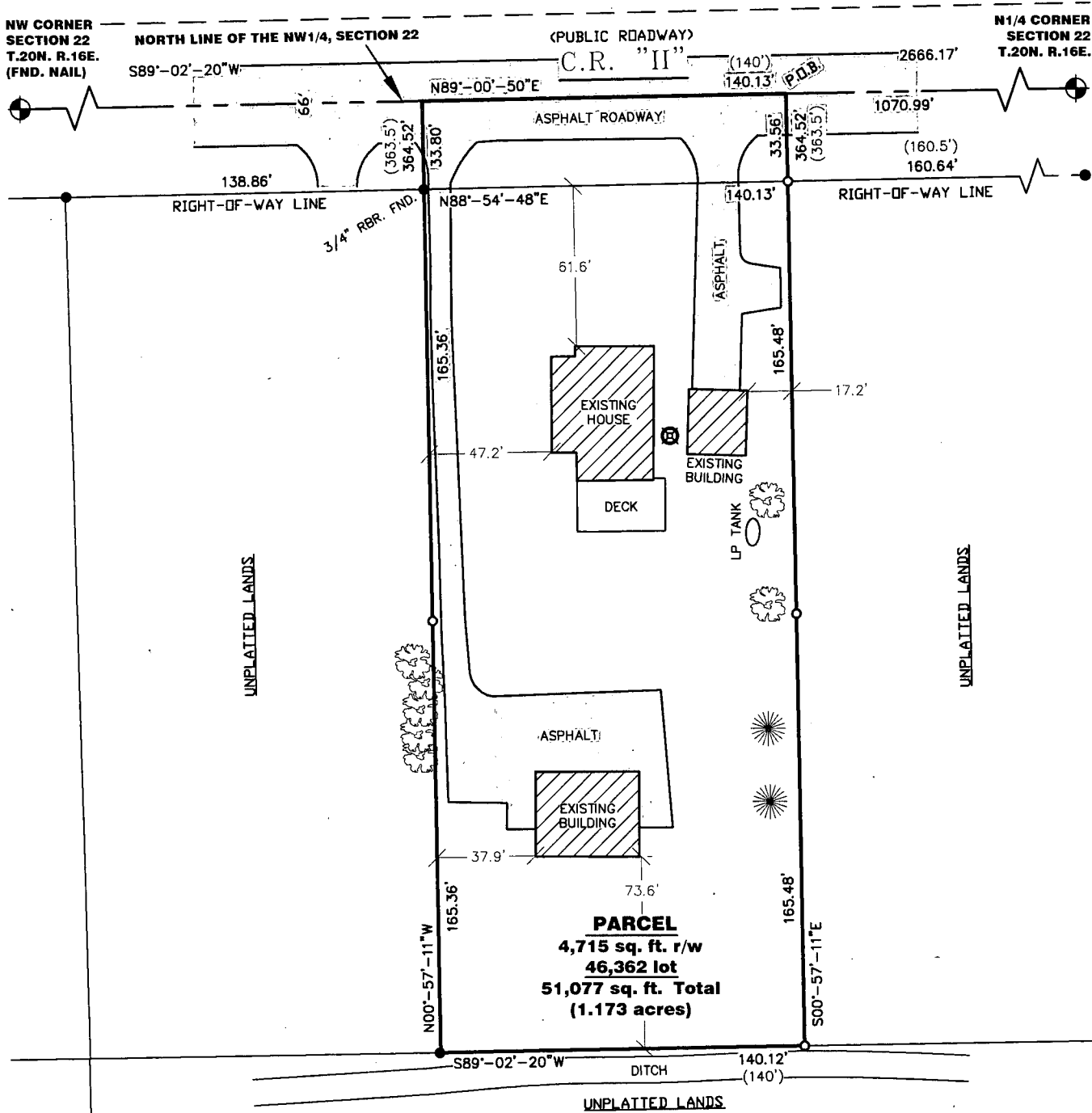


PLAT OF SURVEY

Legal Description

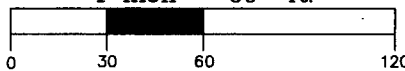
A part of the Northeast Quarter (NE1/4) of the Northwest Quarter (NW1/4) of Section Twenty-Two (22), Township Twenty (20) North, Range Sixteen (16) East, Town of Clayton, Winnebago County, Wisconsin containing 51,077 square feet (1.173 acres) of land and being described by:

Commencing at the North Quarter Corner of said Section 22; thence S89°-02'-20"W 1070.99 feet along the north line of the NW1/4 of said Section 22 to the point of beginning; thence S00°-57'-11"E 364.52 feet; thence S89°-02'-20"W 140.12 feet; thence N00°-57'-11"W 364.52 feet to a point on the north line of the NW1/4 of said Section 22; thence N89°-00'-50"E 140.12 feet along said north line of the NW1/4 of Section 22 to the point of beginning, being subject to any and all easements and restrictions of record.

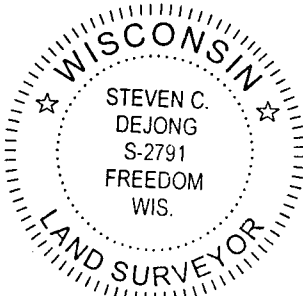
