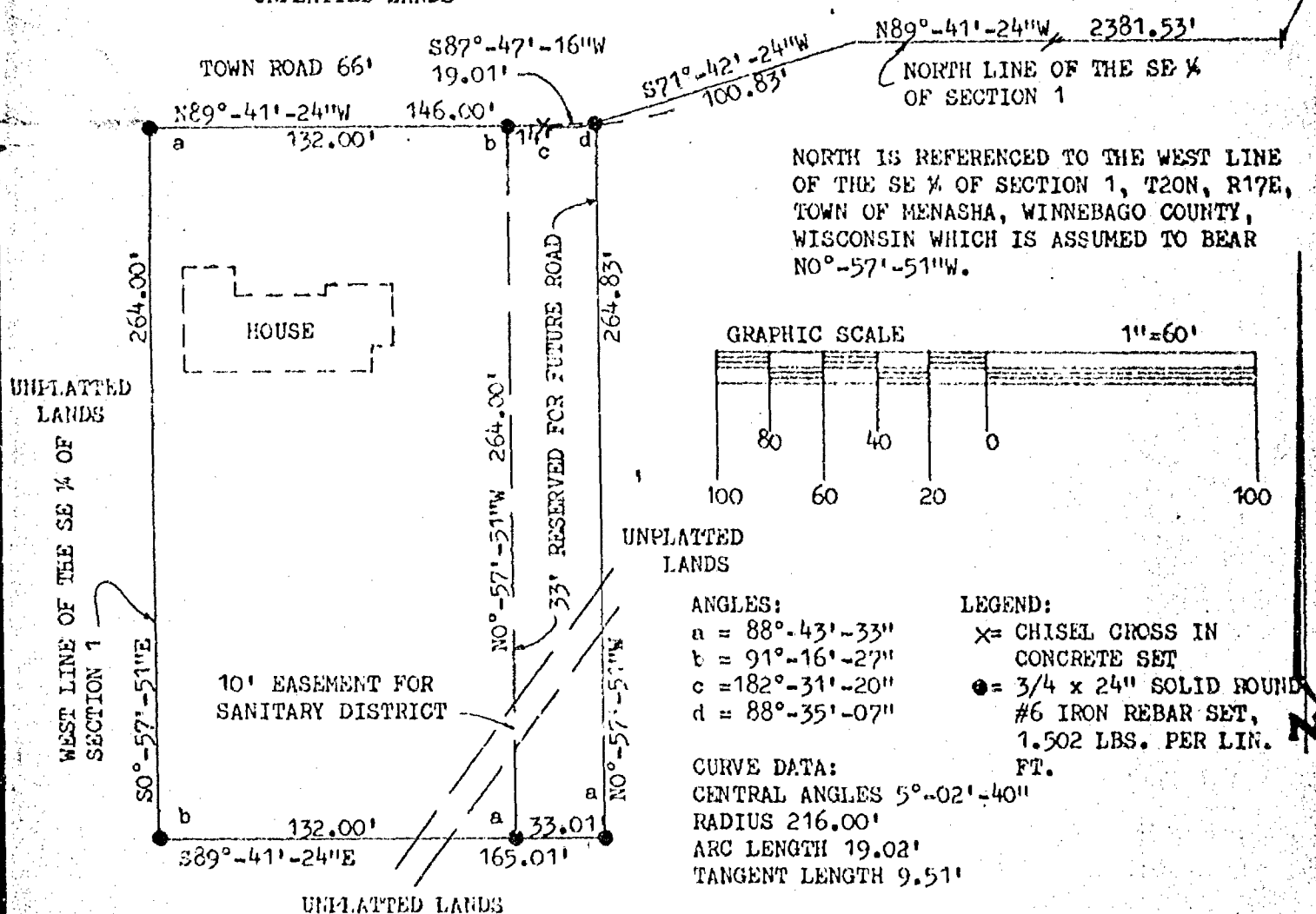

## UNPLATTED LANDS

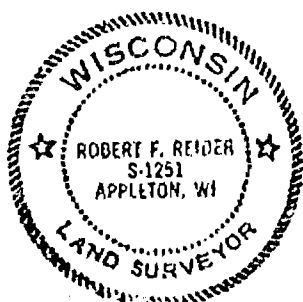


I, ROBERT F. REIDER, REGISTERED WISCONSIN LAND SURVEYOR, CERTIFY THAT I HAVE SURVEYED, DIVIDED AND MAPPED PART OF THE NW ¼ OF THE SE ¼ OF SECTION 1, T20N, R17E, TOWN OF MENASHA. WINNEBAGO COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE EAST ¼ CORNER OF SECTION 1; THENCE N89°-41'-24"W, 2381.53 FEET ALONG THE NORTH LINE OF THE SE ¼ OF SECTION 1 TO THE SOUTH LINE OF A TOWN ROAD; THENCE ALONG THE ARC OF A CURVE OF SAID SOUTH LINE ON A CHORD WHICH BEARS S71°-42'-24"W AND IS 100.83 FEET IN LENGTH TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG THE ARC OF SAID CURVE ON A CHORD WHICH BEARS S87°-47'-16"W AND IS 19.01 FEET IN LENGTH TO THE TERMINATION OF SAID CURVE; THENCE N89°-41'-24"W, 146.00 FEET ALONG SAID SOUTH LINE TO THE WEST LINE OF THE SE ¼ OF SECTION 1; THENCE S0°-57'-51"E, 264.00 FEET ALONG SAID WEST LINE; THENCE S89°-41'-24"E, 165.01 FEET; THENCE N0°-57'-51"W, 264.83 FEET TO THE POINT OF BEGINNING. SAID PARCEL OF LAND CONTAINING 1.00 ACRES OF LAND MORE OR LESS. SUBJECT TO ALL EASEMENTS AND RESTRICTIONS OF RECORD.
