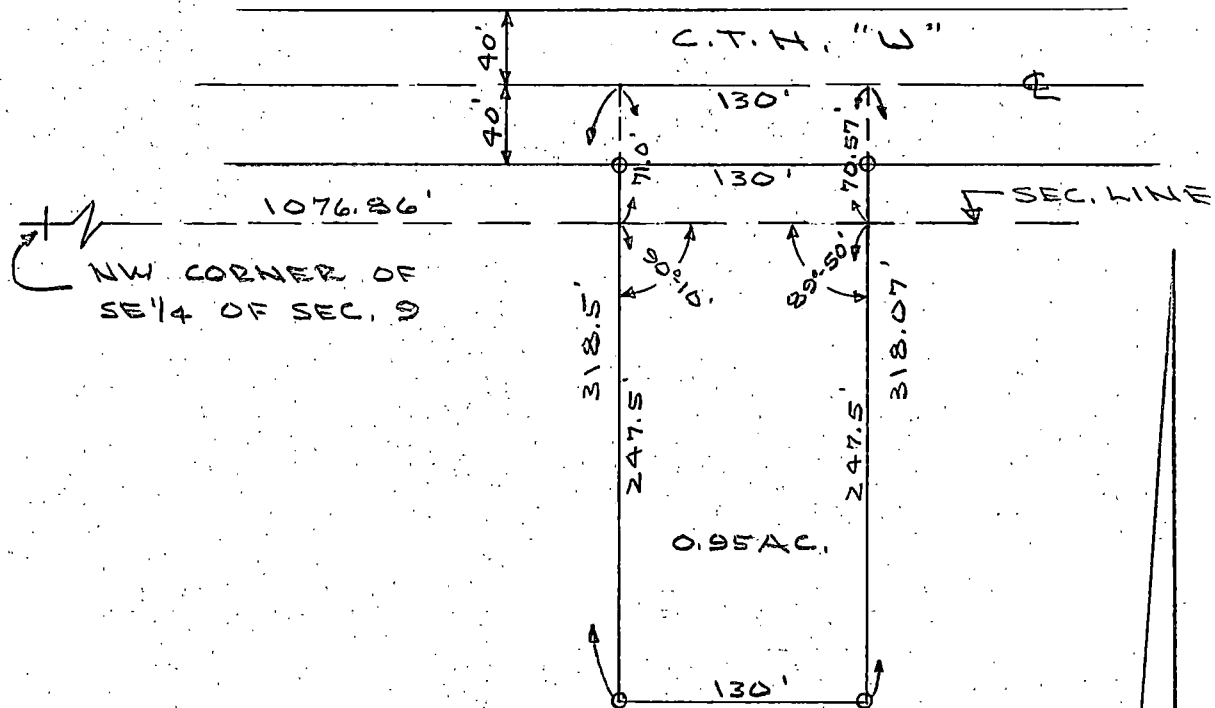

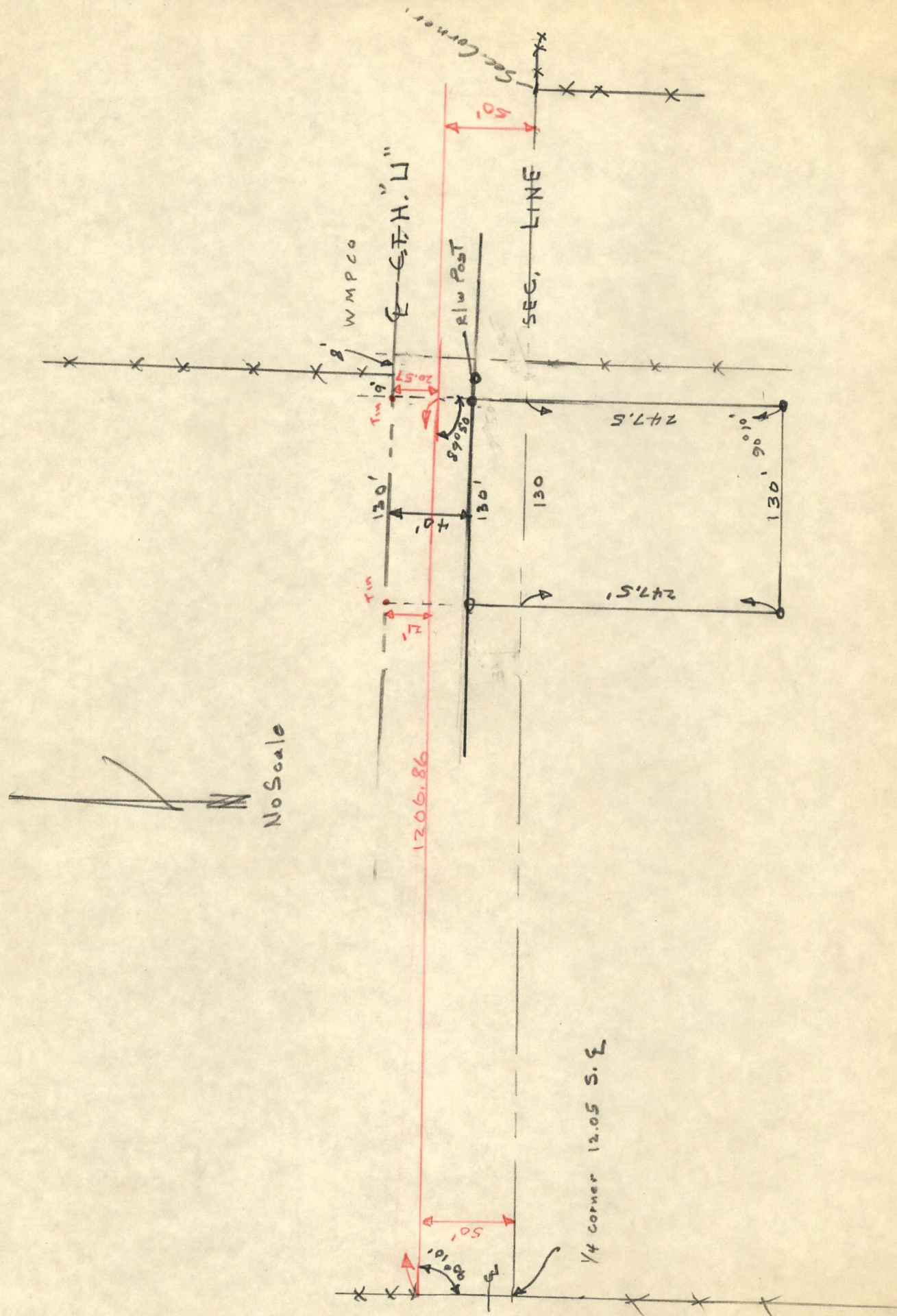

Commencing at the northwest corner of the Northeast $\frac{1}{4}$ of said Section 9; thence Easterly, along the north line of Section 9, 1076.86 feet to the point of beginning of the herein described parcel; thence Southerly, parallel with the west line of the Northeast $\frac{1}{4}$ of Section 9, 247.5 feet; thence Easterly, parallel with the north line of Section 9, 130.0 feet; thence Northerly, parallel with the west line of the Northeast $\frac{1}{4}$ of Section 9, 318.07 feet to the centerline of C.T.H. "U"; thence Westerly, along the centerline of C.T.H. "U", 130.0 feet thence Southerly, 71.0 feet to the point of beginning and containing 0.95 acre of land, more or less.

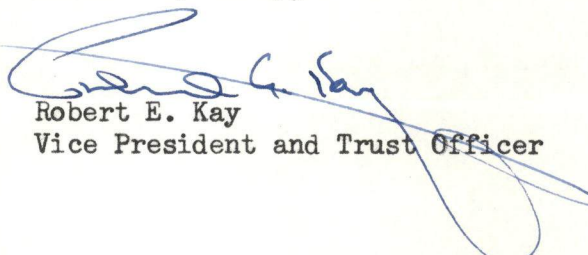
Dear Clyde:

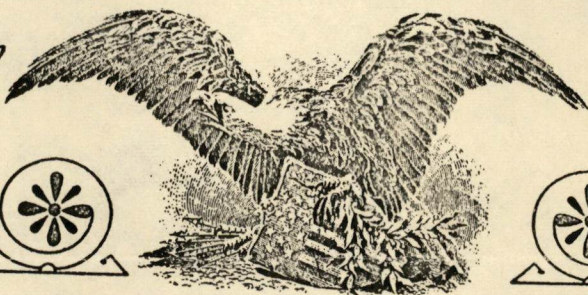
