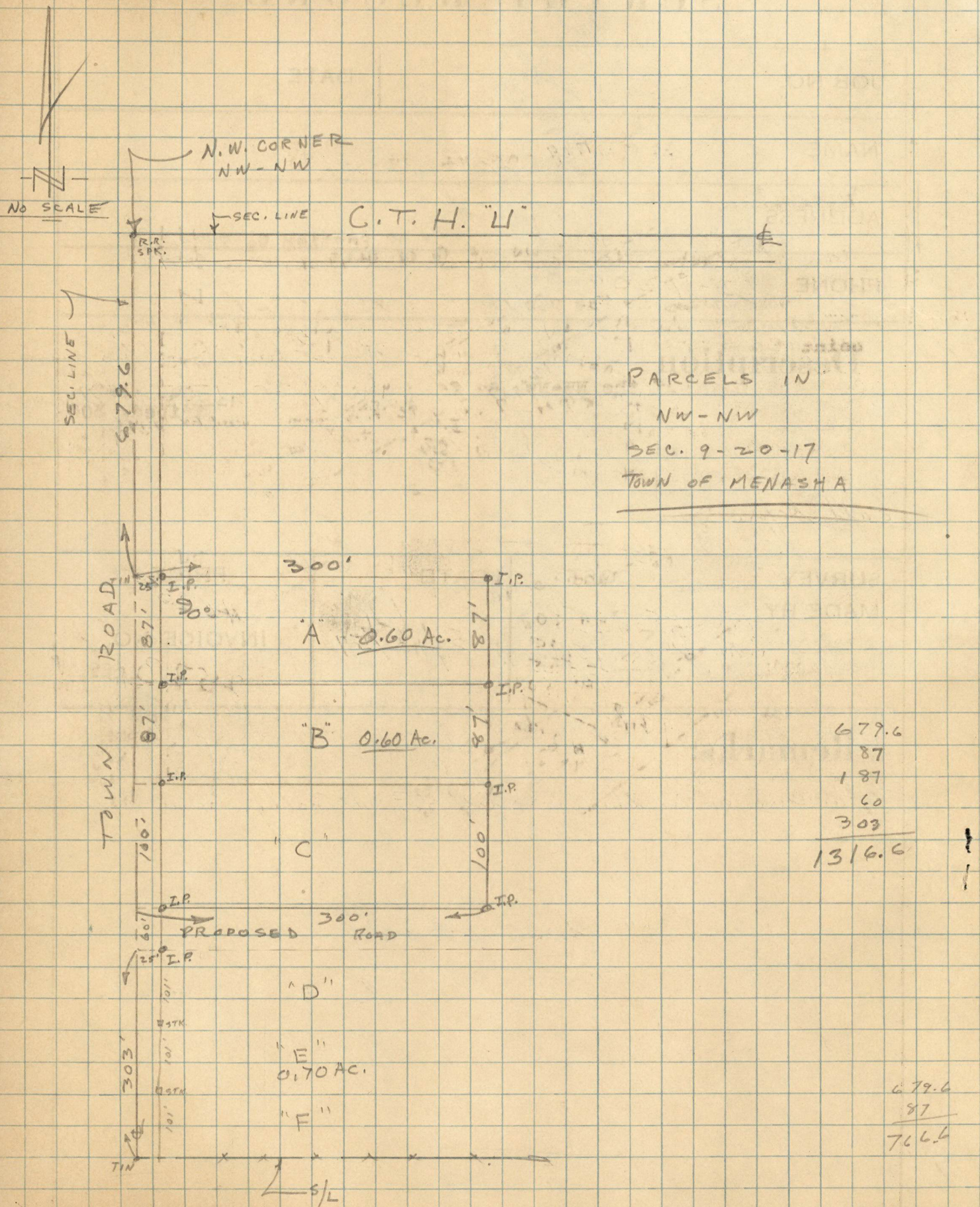

PARCEL "A"

A parcel of land in the NW-NW of Section 9, T20N, R17E, Town of Menasha, Winnebago County, Wisconsin, more fully described as follows:

Commencing at the northwest corner of said NW-NW; thence South, along the west line of the NW-NW, 679.6 feet to the point of beginning; thence East, at right angles to the west line of the NW-NW, 300 feet to a point; thence South, parallel with the west line of the NW-NW, 87 feet to a point, thence West, parallel with the north line of premises herein described, 300 feet to a point in the west line of the NW-NW; thence North, along the west line of the NW-NW, 87 feet to the point of beginning and containing 0.60 acres of land, more or less.

PARCEL "B" "E"

A parcel of land in the NW-NW of Section 9, T20N, R17E, Town of Menasha, Winnebago County, Wisconsin, more fully described as follows;
