All that part of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 16, T20N., R17E. in the Town of Menasha, Winnebago County, Wisconsin, described as follows:- Beginning at an iron pipe on the Easterly R.O.W. line of West Frontage Road that is 1884.37 ft. N88°50'43"E and 530.00 ft. S2°42'41"E and 40.01 ft. N88°50'39"E of the NW corner of said Sec. 16.

From that point running N2°42'41"W along the Easterly R.O.W. line of West Frontage Road 463.35 ft. to a R.O.W. post, thence N42°59'57"E, 110.30 ft. to a R.O.W. post on the Southerly R.O.W. line of Jacobsen Road, thence N88°43'38"E (Recorded as N88°50'43"E) along said Southerly R.O.W. line, 263.93 ft. to a R.O.W. post, thence S48°49'06"E, 98.52 ft. to a R.O.W. post, thence S38°03'30"W along the Westerly R.O.W. line of Co. Trk. Hwy. "PP", 60.97 ft. to a R.O.W. post, thence along the arc of a curve whose chord bears S20°46'22.5"W, 393.97 ft. to a R.O.W. post, thence S5°17'24"W, 69.23 ft. to an iron pipe, thence S88°50'39"W, 207.43 ft. to the said point of beginning.


