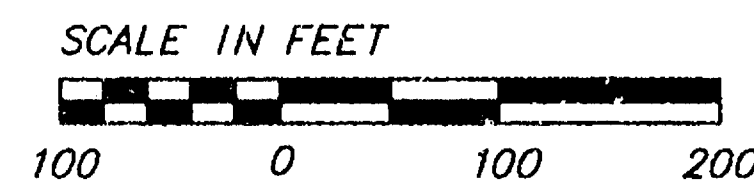


BEARINGS ARE REFERENCED TO THE SOUTH LINE

#### Description

All of the Outlot of Certified Survey Map No. 2950, part of the West 1/2 of the Southwest 1/4 of Section 20 and part of the Northwest 1/4 of the Northwest 1/4 of Section 29, Town 20 North, Range 17 East, Town of Neenah, Winnebago County, Wisconsin more fully described as follows:

Commencing at the South 1/4 corner of said Section 20; thence South 89 degrees 56 minutes 31 seconds West along the South line of said Southwest 1/4 a distance of 1549.79 feet; thence South 69 degrees 33 minutes 20 seconds West along the Centerline of Oakridge Road a distance of 183.48 feet; thence South 71 degrees 27 minutes 12 seconds West along said centerline a distance of 51.88 feet to the point of beginning; thence continuing South 71 degrees 27 minutes 12 seconds West along the said centerline a distance of 34.95 feet; thence North 00 degree 41 minutes 40 seconds East, 434.37 feet; thence South 89 degrees 31 minutes 19 seconds West, 483.50 feet; thence North 05 degrees 33 minutes 52 seconds West, 1309.50 feet; thence South 88 degrees 56 minutes 54 seconds East, 627.00 feet; thence South 00 degree 10 minutes 25 seconds East, 601.34 feet; thence South 87 degrees 34 minutes 25 seconds East, 123.66 feet; thence South 00 degree 10 minutes 25 seconds East, 662.76 feet; thence South 19 degrees 31 minutes 01 seconds East, 20.00 feet; thence North 89 degrees 46 minutes 25 seconds West, 117.50 feet; thence South 00 degree 41 minutes 38 seconds West along the westerly line of said Lot 1 of Certified Survey Map No. 2950 a distance of 117.50 feet; thence South 00 degree 41 minutes 38 seconds West along the westerly line of said Lot 1 of Certified Survey Map No. 2950 a distance of 423.32 feet to the point of beginning, containing 830,875 square feet ( 19.1 acres ).

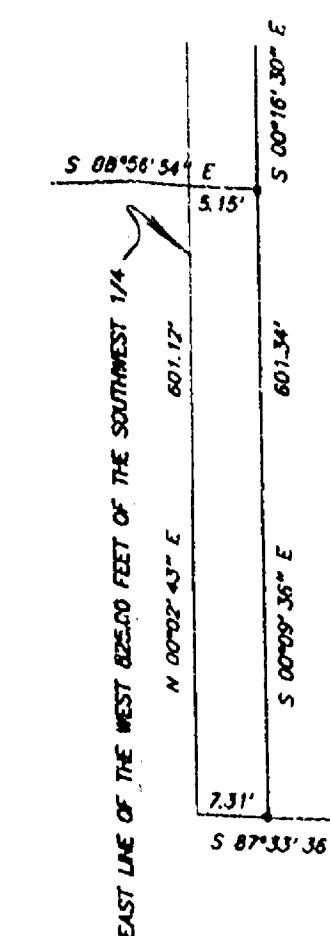

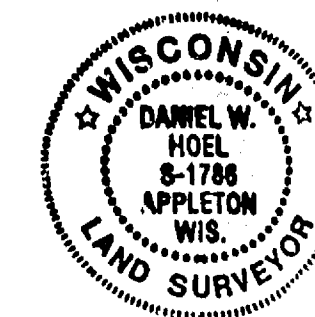
