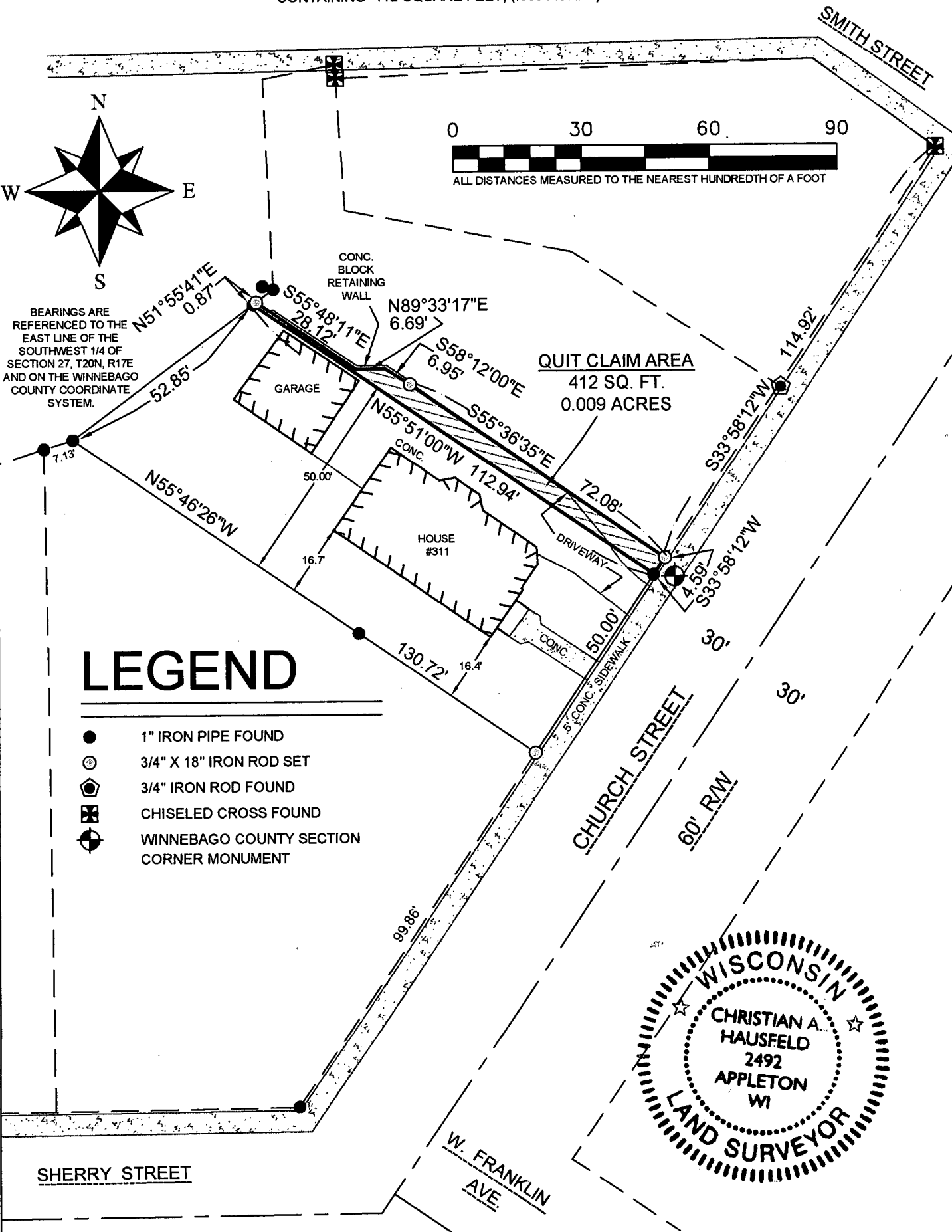


QUIT CLAIM EXHIBIT

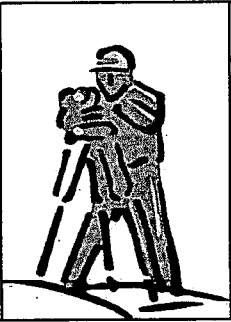
COMMENCING AT THE NORTHEAST CORNER OF BLOCK 21, PER PALMER'S MAP; THENCE S33°58'12"W, 114.92 FEET ALONG THE WESTERLY FIGHT-OF-WAY LINE OF CHURCH STREET TO THE POINT OF BEGINNING; THENCE CONTINUING S33°58'12"E, 4.59 FEET ALONG SAID RIGHT-OF-WAY LINE TO A POINT ON THE NORTHERLY LINE OF THE SOUTH 50.00 FEET OF SAID BLOCK 21; THENCE N55°51'00"W, 112.94 FEET ALONG SAID NORTHERLY LINE OF THE SOUTH 50.00 FEET OF BLOCK 21; THENCE N51°55'41"E, 0.87 FEET; THENCE S55°48'11"E, 28.12 FEET, ALONG THE LOWER LEDGE OF A BLOCK RETAINING WALL TO AN ANGLE POINT OF SAID WALL; THENCE N89°33'17"E, 6.69 FEET, ALONG SAID LOWER LEDGE OF SAID WALL; THENCE S58°12'00"E, 6.95 FEET, ALONG SAID LEDGE OF SAID WALL TO A 3/4" X 18" IRON ROD SET AT END OF SAID WALL; THENCE S55°36'35"E, 72.08 FEET TO THE POINT OF BEGINNING. CONTAINING 412 SQUARE FEET, (.009 ACRES) OF LAND.
