All that part of the North East One Quarter (N.E. 1/4) of the NORTH EAST ONE QUARTER (N.E. 1/4) of Section Thirty-four (34), and of FRACTIONAL LOT ONE (1) of Section Thirty-five (35), all in Township Twenty (20) North, Range Seventeen (17) East, City of Neenah, Winnebago County, Wisconsin, described as follows:

Commencing at the North West corner of the NORTH EAST ONE QUARTER (N.E. 1/4) of Section Thirty-Four (34), Township Twenty (20) North, Range seventeen (17) East, which is the intersection of the centerlines of Cecil Street and Road Street in the City of Neenah, Wisconsin; thence East along the North line of said NORTH EAST ONE QUARTER (N.E. 1/4) Two Thousand One Hundred Forty and Four Tenths feet (2,140.4') to the centerline of Bay View Road; thence South Twenty-eight Degrees Twelve Minutes (28° 12') East along said road centerline Five Hundred Nineteen and five Tenths Feet (519.5') to the point of beginning; thence North forty-nine Degrees Twenty-seven Minutes (49° 27') East Three Hundred Fifty-five and Five Tenths Feet (355.5'); thence South Thirty-eight Degrees Twenty-two Minutes (38° 22') East One Hundred Fifty Feet (150'); thence South Forty-two Degrees Forty-two Minutes (42° 42') West Three Hundred Ninety-four and nine Tenths Feet (394.9'); thence North Twenty-eight Degrees Twelve Minutes (28° 12') West One Hundred Ninety-nine and Five Tenths Feet (199.5') to the point of beginning; also including that land between the extended side lines of the above described parcel lying between the Northeastern line of said parcel and the shore of Lake Winnebago and including a part of Bay View Road Which is already released for highway purposes. Subject to restrictions, covenants and easements of record.

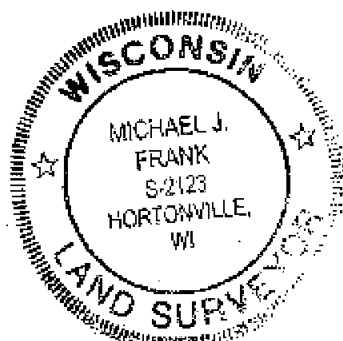
