


PLAT OF SURVEY

Bayview Estates bearings.





Part of Fractional Lot 3, of Section 35, Town 20 North, Range 17 East, City of Neenah, Winnebago County, Wisconsin, more fully described as follows:

The point of beginning is the Northerly most corner of Lot 43, Bayview Estates, a subdivision of record; thence N 06°-35'-25" W, along the Westerly line of out lot 1, of said Bayview Estates, 21.46 feet; thence S 89°-54'-20" W, 153.05 feet to a point on the Easterly line of Evergreen Lane extended Northwesterly; thence S 13°-39'-16" E, along the extended Easterly line of Evergreen Lane, 57.18 feet to the Northwesterly corner of said Lot 43; thence N 76°-20'-44" E, along the Northerly line of said Lot 43, a distance of 146.14 feet to the point of beginning. Said parcel is subject to wetlands restrictions and all easements and restrictions of record. Parcel contains 5609 square feet.

The point of beginning is the Northwesterly corner of Lot 43, Bayview Estates, a subdivision of record; thence N 13°-29'-16" W, along the Easterly line of Evergreen Lane extended, 57.18 feet; thence S 89°-54'-20" W, 30.86 feet; thence S 13°-39'-15" E, along the centerline of Evergreen Lane previously dedicated in Bayview Estates, 64.42 feet; thence N 76°-20'-44" E, along previously dedicated Evergreen Lane, 30.00 feet to the point of beginning.
