



DRAINAGE PLAN FOR FIRST ADDITION TO KAITLYNN

4. Backfill and compact the excavated soil.


CONSTRUCTION OF A STRAW SALE BARRIER


Set posts and excavate a 4"x4" trench upslope along the line


2. Staple wire fencing to

4. Backfill and compact the excavated soil.






Extension of fabric and wire into the trench. Filter Fabric ...




