

PLAT OF SURVEY

KNOWN AS 2513 FOND DU LAC ROAD. BEING THAT PART OF FRACTIONAL LOT TWO IN SECTION 36, TIBN, R16E, IN THE FOURTEENTH WARD, CITY OF OSHKOSH, WINNEHAGO COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCING AT THE CENTERLINE OF HIGHWAY THAT IS AN EXTENSION OF DOTY STREET IN THE CITY OF OSHKOSH AT A POINT 603 FT. SOUTHERLY OF THE INTERSECTION OF THE CENTERLINE OF SAID HIGHWAY WITH THE NORTH LINE OF SAID FRACTIONAL LOT 2, SAID POINT BEING IN THE CENTER OF A CONCRETE BRIDGE (AS PER SURVEY OF R.F. WOLVERTON, 4/16/45), THE PLACE OF BEGINNING, THENCE SOUTH 23'27' EAST ALONG THE CENTERLINE OF SAID HIGHWAY 155.7 FT., THENCE SOUTH 71'08' WEST 305.4 FT., THENCE NORTH 71'08' EAST 130 FT. TO THE CENTERLINE OF A CREEK COMMONLY KNOWN AS GLATZ CREEK THENCE SOUTH 5677' EAST 86 FT., THENCE SOUTH 6977' EAST 112 FT. TO THE WESTERLY LINE OF SAID HIGHWAY, THENCE NORTH 70'07' EAST 32 FT. CORNER OF CIMARRON ESTATES CONDOMINIUM, THENCE SOUTH 71"20'12" WEST ALONG A NORTHERLY LINE OF SAID CONDUMINIUM 277.57 FT., THENCE NORTH 20"18'54" WEST ALONG AN EASTERLY LINE OF SAID DOCUMENT 292.88 FT. TO THE POINT OF BEGINNING OF THE PARCEL TO BE DESCRIBED, THENCE CONTINUING NORTH 20"18'54" WEST 53.91 FT. TO A POINT IN THE CENTERLINE OF GLATZ CREEK, THENCE SOUTH 88'09'47" EAST ALONG A LINE THAT APPROXIMATELY DESCRIBES THE CENTERLINE OF GLATZ CREEK 151.29 FT., THENCE SOUTH 70'58'06" WEST 140.11 FT. TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 3,775 SQUARE FEET AND IS SUBJECT TO ALL EXISTING EASEMENTS AND RESTRICTIONS OF RECORD.
