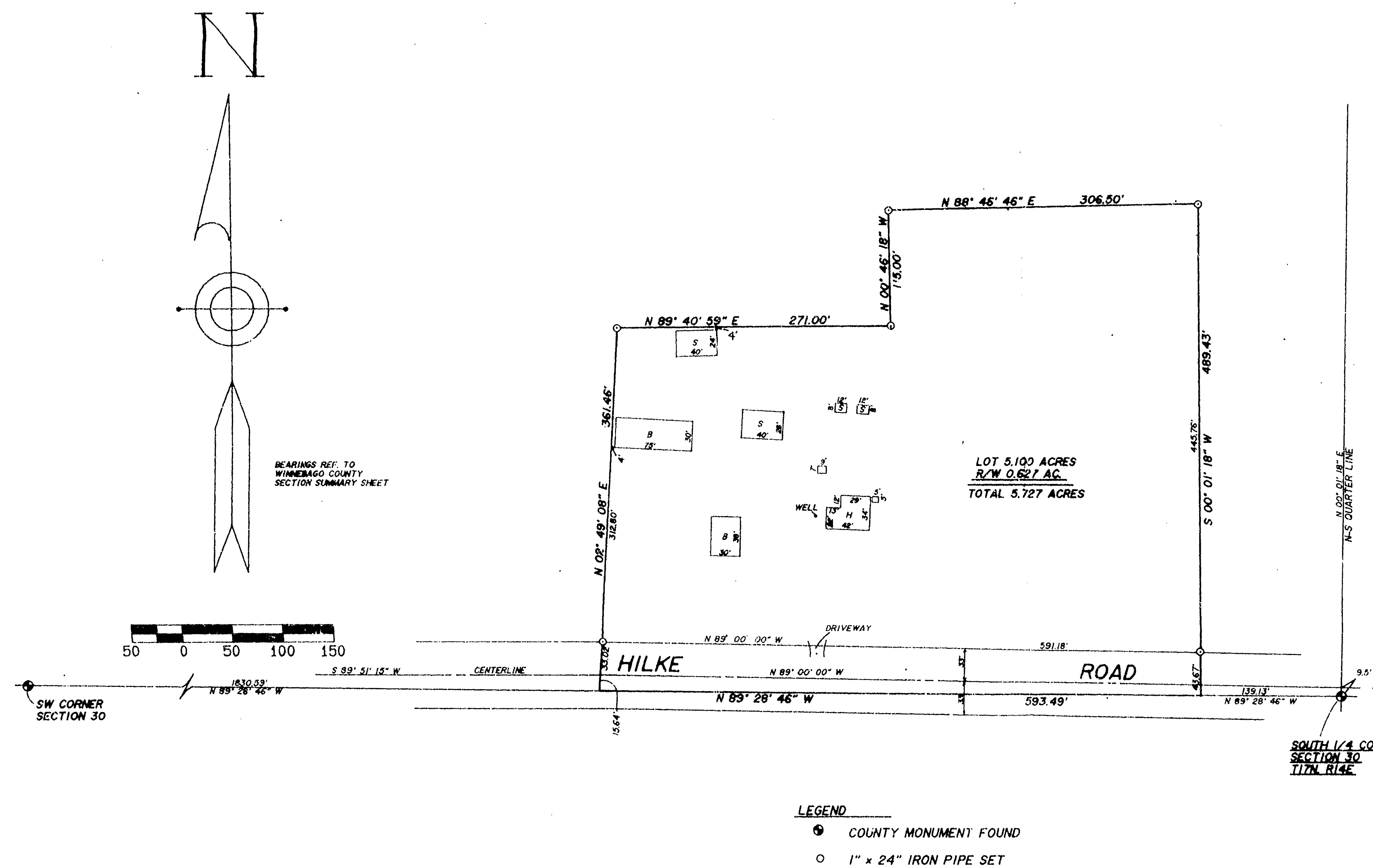


THOMAS HILKE LOT SURVEY

SURVEYOR'S CERTIFICATE

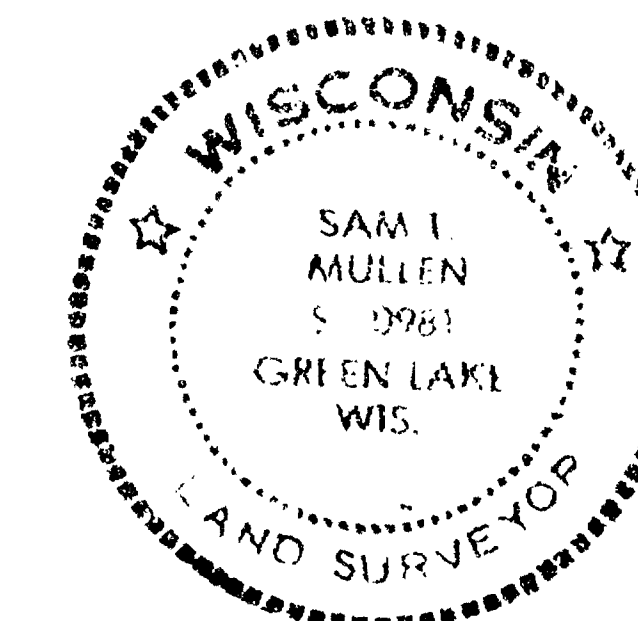

Commencing at the South 1/4 Corner of said Section 30; thence N 89°-28'-46\" W along the south line of the Southwest 1/4, 139.13 ft. to the Point of Beginning; thence continuing N 89°-28'-46\" W 593.49 ft.; thence N 02°-49'-08\" E 361.46 ft.; thence N 89°-40'-59\" E 271.00 ft.; thence N 00°-46'-18\" W 115.00 ft.; thence N 88°-46'-46\" E 306.50 ft.; thence S 00°-01'-18\" W, parallel to the north-south quarter line of Section 30, 489.43 ft. to the Point of Beginning, containing 5.727 acres; being subject to the right-of-way for Hilke Road, as now exists, along the south line of the above described parcel; and being subject to all other easements and restrictions of record, if any.
