That I have surveyed, divided and mapped, at the direction of Joy Clarke, all of the Southeast 1/4 of the Northeast 1/4 of Section 6, Town 17 North, Range 16 East, Tawn of Nekimi, Winnebago County, Wisconsin described as follows:

Beginning at the East 1/4 corner of sold Section 6; thence South 89 degrees 32 minutes 14 seconds West, along the South line of sold Northeast 1/4 a distance of 1330.26 feet; thence North 01 degrees 00 minutes 26 seconds West, along the west line of sold Southeast 1/4 of the Northeast 1/4 a distance of 1336.11 feet; thence North 89 degrees 31 minutes 49 seconds East, along the north line of sold Southeast 1/4 of the Northeast 1/4 a distance of 1332.98 feet; thence South 00 degrees 53 minutes 24 seconds East, along the east line of sold Northeast 1/4 a distance of 1336.25 feet; to the point of beginning, containing 1,779,222 square feet (40.845 acres).
