All that part of the NW 1/4 of the SW 1/4 of Sec. 36, T.19N., R.14E. in the Town of Poygan, Winnebago County, Wisconsin, described as follows: Beginning at a Berntsen monument at the center of said Sec. 36. From that point running N.88°51'59"E. along the North line of the SW 1/4 of said Sec. 36, 400.00 ft., thence S.01°04'06"E., 588.39 ft., thence S.88°51'59"W., 400.00 ft., to the Westerly line of the SW 1/4 of said Sec. 36, thence N.01°04'06"W., along said Westerly line, 588.39 ft. to the said point of beginning. Being a parcel of land of 5.403 acres. Reserving therefrom the northerly 33.00 ft. presently used for road purposes. Subject to all easements and restrictions of record.

PARCEL 2

All that part of the NW 1/4 of the SW 1/4 of Sec. 36, T.19N., R.14E. in the Town of Poygan, Winnebago County, Wisconsin, described as follows: Beginning at a point on the northerly line of said SW 1/4 that is 400.00 ft., N.88°51'59"E. of a Berntsen monument at the center of said Sec. 36. From that point continuing N.88°51'59"E. along said northerly line, 400.00 ft., thence S.01°04'06"E., 588.39 ft., thence S.88°51'59"W., 400.00 ft., thence N.01°04'06"W., 588.39 ft. to the said point of beginning. Being a parcel of land of 5.403 acres. Reserving therefrom the northerly 33.00 ft. presently used for road purposes. Subject to all easements and restrictions of record.

From that point running S.01°04'21"W. along the East line of the SE 1/4 of said Sec. 36, 1782.64 ft., thence S.88°50'16"W., 610.01 ft., thence S.01°04'21"W., 856.90 ft. to the South line of said Sec. 36, thence S.88°50'16"W. along said south line, 2034.14 ft. to the South 1/4 corner of said Sec. 36, thence N.01°04'06"W., 2052.47 ft., thence N.88°51'59"E., 800.00 ft., thence N.01°04'06"W., 588.39 ft. to the Northerly line of the SE 1/4 of said Sec. 36, thence N.88°51'59"E. along said northerly line, 1843.95 ft. to the said point of beginning. Being a parcel of land of 137.451 acres. Reserving therefrom the portions lying within the right of way of Oakhill Rd. and Brodrick Rd. presently used for road purposes. Subject to all easements and restrictions of record.



PARCEL 4

Being a parcel of land of 12.00 acres. Reserving therefrom that portion lying within the right of way of Brodrick Rd. presently used for road purposes. Subject to all easements and restrictions of record.
