

MAP OF SEC 22 TOWNSHIP NO 20 RANGE NO 14 EAST TOWN OF WOLF RIVER









MAP OF SEC 22 TOWNSHIP NO 24 RANGE NO 14 TOWN OF WOLF RIVER WISCONSIN




I began at a iron stake set at the corner of Sec 22-23-26-27 ran North on Sec line bet Sec 22 and 23 $V 3^{\circ} 45'$ at 79.19 intersect Sec corner of 14-15-22-23 2.20 chs East of stake south corrected $V 5^{\circ}$ at 2970 set iron gas pipe for $1/16$ Se as instructed I then ret to the N E corner of Sec 22 thence west bet Sec 15 and 22 $V 2^{\circ} 45'$ at 2000 set gas pipe for $1/8$ corner at 4000 set gas pipe for $1/4$ Sec at 4450 left Bank of Wolf River I then ran lines bet lots land 2 by proportional measurement and set iron stake as shown on within map marked in Red Ink


Subdivision of Part of Sec 22 Town 20 Range 14 East Town of Wolf River

I Began at the 1/4S Bet Sec 22 & 27 where I had set a cedar stake in 1894 the stake being badly decayed I set for new corner a 1 1/2 inch gas pipe 10 ft long marked with cold chisel 1 1/4S drove it down 8 ft in the ground left 2 ft out of ground with figures in plain sight I then took the Variation of line Bet Sec 22 & 27 and found it to be 2⁰45' I then measured East to where the Sec corner of 22-23-26-27 should be but could find no corner that I had established in 1894 I found two of my old stakes Bet Sec 26 & 27 that I had set in 1894 I then chained North V 3045' at the intersection of the two Sec lines I established the Sec corner of Sec 22-23-26-27 a 1 1/2 inch gas pipe 11 ft long marked with cold chisel I then ran out and set iron stakes as shown on the above map marked in Red Ink thus (o)

MAP OF SEC 23 TOWNSHIP NO 20 RANGE NO 14 EAST TOWN OF WOLF RIVER




